产品简介 / PRODUCT INTRODUCTION

银杏(Ginkgo biloba L.)作为已存在的最古老树种之一,在植物界被称为"活化石"。在中国,银杏在很 长一段历史中都被广泛应用于中医,用于治疗心血管疾病,提高记忆力等。而在欧洲、美国以及世界各地 也被广泛研究和开发应用,到目前为止,银杏相关的膳食补充剂,仍然被人们所推崇,并且大量应用于各 种药用处方中。

银杏提取物(GBE)为以干燥银杏叶为基础,通过一系列物理分离和提取过程得到的干燥粉末。主要成分 为,以槲皮素(Q)、山奈酚(K)和异鼠李素(I)为代表的银杏黄酮,以及银杏内酯。GBE是现代科学技 术开发出的植物药(属中药)最成功的案例之一。

Ginkgo biloba, known as one of the oldest trees in the world, is called the living fossil in the plantage. In the history of China, Ginkgo has been applied to traditional Chinese medicine for a long period in curing the cardiovascular diseases and improving the memory. It is also widely researched and developed in Europe, America and other area around the world. By far, dietary supplement involving Ginkgo is still respected by people, and is usually used in the medicinal prescription.

Ginkgo biloba extract adopts ginkgo leaf as the fundamental, and made it into dry powder through a series of physical separation and extraction process. The main content includes quercetin, kaempferol and ginkgetin represented by isorhamnetin, as well as the bilobalide. GBE is one of the most successful botanical drugs developed through modern technology.
